Prepare trading and profit and loss account for the year ended Dec. 31<sup>st</sup>, 2011, and a balance sheet as on that date after the following adjustments:

1. Provision required for bad debts is 5%.
2. Salaries outstanding Rs. 500.
3. Closing stock of stationery is valued at Rs. 75.
4. Depreciate building by 20%.
5. Closing stock is valued at Rs. 9,900.

Q. 3. In taking out the Trial Balance the accountant finds that the total of the credit side exceeds that of debit side by Rs. 2,410. He places the difference to a suspense account and subsequently detects the following mistakes:

- (a) Stationary purchased for Rs. 890 but debited to stationary account as Rs. 980.
- (b) A sum Rs. 650 received from Alam was credited twice in his account.
- (c) Wages Rs. 250 paid for installing a machine were debited to wages account as Rs. 520.
- (d) A sale of Rs. 350 was entered in the purchase book as Rs. 530 but customer's account was correctly debited with Rs. 350.
- (e) A sale of Rs. 1,000 to Fawad was credited to his account twice.
- (f) Old furniture sold for Rs. 6,000 was passed through sales book.

**Pass rectifying entries and prepare suspense account.**

Q.4. Balance of cash at bank as shown by the cash book of Jamal brothers on 30th June, 2012 was Rs. 8,520. On comparing it with the pass book, following differences were noted:

1. Cheques sent for collection amounting to Rs. 5,100 have not been cleared by the bank so far.
2. Cheques issued but not presented for payment Rs. 3,000.
3. Bank charges Rs. 50 not entered in the cash book.
4. There was a credit of Rs. 220 in the pass book in respect of interest which was not recorded in the cash book.
5. A customer deposited Rs. 1,500 direct in the bank account but it was entered only in the pass book.
6. According to the standing orders of Jamal brothers, the bankers have made the following payments by debiting their account:
  - Life insurance premium Rs. 450
  - Rent Rs. 300

Require: Prepare a bank reconciliation statement as on 30<sup>th</sup> June, 2012.

You are required to show by means of a statement as to how would you arrive at net profit for the year ended 31<sup>st</sup> December 2009 if the accounts were maintained on cash basis.

- Q. 6. On 1<sup>st</sup> January 2002, X sold goods to Y for Rs. 50,000 @ 10% trade discount. On the same date X drew a bill on Y for the amount at 4 months which Y accepted. Y got the bill discounted with his banker for Rs. 40,000. On the due date bill is dishonored and bank paid Rs. 50 as noting charges. Y paid Rs. 10,000 in cash and accepted another bill for the balance along with interest Rs. 100. On the due date of new bill, Y honored his acceptance.

Pass journal entries in the books of X and Y.

- Q.8. Amar, Akbar and Abid are partners in a business and their capitals on 1<sup>st</sup> April, 2001 are Rs.20,000; Rs. 16,000 and Rs. 4,000 respectively. The partnership deed provides that:

- 5% interest is to be allowed on capitals.
- Abid gets Rs. 2,000 as annual salary.
- Akbar gets commission to the extent of Rs. 1,200 annually.
- Profits to be divided in the ratio of 2:1:1.
- Drawings Amar Rs. 6,000; Akbar Rs. 5,000 and Abid Rs. 4,000.

The Profits for the year ending on 31<sup>st</sup> March, 2002 without taking into account the above facts are Rs. 17,200. Draw Profit & Loss Appropriation A/c, showing above transactions in the allocation of profits between partners and Partner's Capital Accounts under fluctuating method.

- Q. 9. Apple sent 10 lap tops to Orange at Rs. 20,000 each to be sold on consignment basis. Expenses paid by Apple on consignment were Rs. 15,000. During transit, 2 lap tops were totally damaged due to accident. Orange received the delivery of remaining lap tops and sold 5 lap tops at Rs. 30,000 each. Expenses paid by Orange were; unloading Rs. 1,000, octroi duty Rs. 500 and carriage Rs. 8,000. He charged 5% commission on sales and 2% del credere commission. Orange cleared the balance. Rs. 20,000 was received from insurance company on account of claim. Prepare necessary ledger accounts in the books of Apple.
