Undertaking:

I, the undersigned hereby solemnly affirm and declare that:

- 1. I undertake that if I have been extended with transport facility, I will abide by the provisions of the act, statute, regulations, ordinances and rules of the University and all other documents or instructions, as framed, amended, and enforced from time to time in any form and manner in this regard.
- 2. The University reserves the right to frame, amend, revoke, repeal and enforce the Rules & Regulations, as and when deemed fit; and it shall be my duty to keep myself well versed and updated with the amended Rules & Regulations as applicable from time to time; the University shall not be bound or responsible to intimate me separately in any manner, in this regard.
- 3. I agree that I shall avail the transport facility for the full academic session and if due to any reason I withdraw and do not avail this facility during the academic year I shall pay the transport fee for the full academic session.
- 4. I understand that the University may provide me the transport facility at its own or through other arrangements as it may deem fit.
- 5. I agree that I shall not be entitled for transport facility as a matter of right by submitting this enclosure of the common admission form.
- 6. I agree that I shall board the transport vehicle from the assigned boarding point/location only. I further agree that I shall make the required adjustments for my transport facility as per the specific requirement of the University for a specific time due to any reason, whatever it may be.
- 7. I understand that the University has complete authority to inspect the transport vehicle or any of my personal belongings during transit or otherwise at any time in and outside the campus.
- 8. I understand that the transport vehicle allotted and various provisions and facilities in the transport may vary or be subject to change from time to time as decided by the University.
- 9. I agree that I shall carry the transport identity card all the time during transit in the transport vehicle and shall be liable to produce the same as and when the concerned authorities ask for it.
- 10. I agree that the University shall not be liable for any damage, loss, accident, and/or mis-happening caused to me while in transit or otherwise.
- 11. I understand and agree that I shall be liable to pay the transport charges/fee for the industrial visits, tours, bridge courses, workshops, practical, training, and placement visits or for visiting such other places, and events as may be specified by the University from time to time in any addition to the transport fee for the academic session.
- 12. I agree that if declared ineligible for appearing in any examination of the University, on account of a shortage of attendance or any other reason or my detention during the duration of the program due to misconduct or any other reason whatsoever, I shall not avail of transport facility if University authorities so decide, at any time and I would not be entitled to any refund of fee. Availing of transport facility in the forthcoming term/semester may be allowed only at the sole discretion of the University.
- 13. I understand and agree that transport fees and related charges are subject to revision from time to time as decided by the University.
- 14. I shall be liable to pay for any damage caused by me to the transport vehicle or provisions therein either alone or jointly with others and will face disciplinary action.
- 15. I agree that I may be subject to all possible disciplinary action including but not limited to cancellation of my admission or transport facility at any time as decided by the University in case I have been found guilty of any sort of disobedience of any of the transport rules and the regulations notwithstanding legal action under the law of the land and in that case I shall not be entitled to claim for refund of fees and other amounts paid unless otherwise decided by the University.
- 16. I agree that I will deposit a fine of 10% of the transport fee If, I fail to deposit the monthly installment by the 10th of each respective month.
