- 3- Call Deposit Receipt (CDR Refundable) in favor of Treasurer MUST is also required.
- 4- All Government / Local Taxes will be deducted at the time of payment under the rules.
- 5- Quantity of Items given in tender document may be increased or decreased at time of supply order as per approval of The Competent Authority up to 15% of quantity given in tender document.
- 6- Incomplete / conditional tender will not been entertained.
- 7- All pages of Quotations should be marked i.e. (1, 2, 3) etc duly signed in by an authorized person. Separate quotation for each Department / Head is required.
- 8- PPRA rules shall be followed during procurement.
- 9- Single stage, single envelop procurement proceeding of PPRA Rules shall be opted.
- 10-Blacklisted firms / companies/suppliers/bidders/distributers are prohibited for participation and all bidders shall furnish an affidavit / certificate that they are neither blacklisted nor in conflict with Govt. anywhere in the territory of the state of AJ&K, Federally administrated areas or Islamic Republic of Pakistan.
