Introduction:

Functions of QEC at MUST include

- To make sure that each discipline, field and subject area meet the recognized quality standards on national and international level.
- To promote public confidence that the quality and standards of the awarded degrees are enhanced and safeguarded.
- In collaboration with the Higher Education Commission (HEC), industry and Departments
 making efforts in devising and reviewing curriculum so that it could meet the prescribed
 standards.
- Developing qualification framework by setting out the attributes and abilities as per expectations of all the stakeholders.

- To develop quality assurance processes and methods of evaluation and assessment to affirm that the quality standards are being maintained.
- To devise automated procedure for monitoring and evaluation of new programs through departmental reviews, student feedback and employer feedback.
- To make continuous process of planning, coordinating and following up on the self-assessment (SA)activities in the University.
- To make a mechanism for the implementation plan and corrective actions regarding
 assessment and self-reviews. The academic Departments shall respond to the QEC
 regarding the corrective action and implementation plan. QEC shall review the
 implementation plan after each semester to assess the progress.
- The QEC will adopt and respond to the Assessment and reviews made by HEC in a systematic process of gathering, reviewing and using important quantitative and qualitative data and information for learning and evaluating environment in the University.
- The QEC reviews the SARs made by the Departments and conducted PGP reviews for the improvement of various academic programs. The PGPR team, program Assessment Team (AT) prepared in accordance with prescribed format. On the recommendations of QEC. The Vice Chancellor/Competent authority will constitute AT and Pts.

Plagiarism Policy

The university has adopted the HEC Anti-Plagiarism Policy. The QEC in collaboration with AS&RB remained engaged in developing a plagiarism-free culture in the University. For the purpose awareness seminars and training will be organized for the students and faculty members. All the synopses and theses and dissertations undergo an examining process at ASRB and QEC for plagiarism checking.
