- b) Tender Fee (Non-Refundable and Mandatory) is **Rs. 2,000/-** which can be paid through University Bank challan in HBL/online challan from Allied bank (<http://challan.must.edu.pk/>) or demand draft in favour of Treasurer Mirpur University of Science & Technology (MUST) and receipt must be attached with quotation/bid.
- c) Call Deposit Receipt (Refundable) in favour of Treasurer Mirpur University of Science & Technology (MUST) is mandatory.
- d) All Government / State of AJK Taxes will be deducted at the time of payment under rules.
- e) Quantity of items given in tender document may be increased or decreased with the approval of the Competent Authority.
- f) Incomplete / conditional tender will not be entertained.
- g) PPRA rules shall be strictly followed during procurement.
- h) Single stage, two envelope procurement proceeding of PPRA Rules shall be opted.
- i) Blacklisted firms / companies/suppliers/bidders/distributers are prohibited for participation and all bidders shall furnish an affidavit /certificate that they are neither blacklisted nor in conflict with Govt. anywhere in the territory of the state of AJ&K, federally administrated areas or Islamic Republic of Pakistan.
- j) The procuring agency reserves the right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal by invoking PPRA Rules.
